1. Every affiliate member must be part of an office/branch with membership with SNR.
2. New Offices will be charged \$100 per office for setup.
  - a. The Primary Member/Office Manager/Responsible Member is included with the office setup.
  - b. Offices may have multiple affiliate members, each member costs \$25.
    - i. Additional Affiliate must complete the application
3. Please see the schedule of dues below as a guide for the month applied as they are prorated based on the month the application is submitted to the offices at SNR.
  - a. Payment is due upon processing, SNR Staff will call to collect payment.
  - b. Application will not be active until payment is processed.
    - i. All checks must be submitted to SNR Offices in Reno by mail or in-person
    - ii. Mail to SNR Reno Offices 5650 Riggins Ct. Reno, NV 89502 attn accounts receivable
    - iii. Include your invoice number on the check stub
    - iv. Applications or checks mailed or dropped off at the Carson Office will have a delay in processing.
4. Annual Affiliate membership dues are invoiced in October of the current year are due in full based on SNR accounting procedures & fiscal policy, no later than December 31st of the current calendar year.
